

Pennsylvania Gymnastics Hall of Fame

1. Eligible Candidates -- Candidates to be eligible must meet the following requirements:

Nominations for an athlete: Should use the following criteria

- A period of 5 years since last competition to which the individual competed.
- Has been a National Champion or National Team Member at either Level 9 or 10
- Collegiate Gymnast or Champion
- Nominations should include: Gymnastics club/school where athlete trained. Please include the number of years they trained and their coaches
 - Athlete's competitive history in chronological order.
 - Highlights States, Regional, and or National titles
 - Honor or awards awarded to the athlete
 - Any additional information that may be deemed important

Nominations for a coach: Should use the following criteria

- Minimum of fifteen years of experience as a coach.
- Coached athletes who were: (to keep in consideration of their body of work)
 - o National Champions or National Team Members
 - o Olympians
 - o State Championship Teams
- Service or volunteer for the State of Pennsylvania in an official capacity
- Nominations should include: Gymnastics club/school where coach trained. Please include the number of years they trained at each club/school
- Athlete's coached and their competitive achievements
- Impact they have had on the sport of gymnastics in Pennsylvania
- Any additional information that may support the nomination such as awards received or other contributions to the sport (athlete, judge, volunteer), presentations or publications, etc.

Nominations for an Judge: Should use the following criteria

- Minimum of fifteen years of experience as a judge.
- Judged at National, International or Olympic championships
- Service or volunteer for the State of Pennsylvania in an official capacity
- Nominations should include: Judging history – (When they achieved their ratings)
- Significant competitions they judged at
- Lectures, clinics and other educational accolades
- Board member/position or role in an official capacity for the State of Pennsylvania

- Any additional information that may support the nomination such as awards received or other contributions to the sport (athlete, judge, volunteer), presentations or publications, etc.

Nominations for a Lifetime Achievement: Should use the following criteria

- Minimum of fifteen years of experience as a coach.
- Impact and influence on Pennsylvania Gymnastics
- Service or volunteer for the State of Pennsylvania in an official capacity
- Awards, achievements, contributions, clinics, volunteer, presentation, publications,
- Nominations should include: Gymnastics club/school where coach trained. Please include the number of years they trained at each club/school
- Athlete's coached and their competitive achievements
- Any additional information that may support the nomination such as awards received or other contributions to the sport (athlete, judge, volunteer), presentations or publications, etc.

Exceptions for ALL Categories:

- Any person on USAG's permanently ineligible list shall never be an eligible candidate.
